

ITU conference registration terms and conditions

By accessing the registration site at <http://itu2017conf.airtours.hu>, you are agreeing to be bound by these terms of service, all applicable laws and regulations, and agree that you are responsible for compliance with any applicable local laws. If you do not agree with any of these terms, you are prohibited from using or accessing this site. The materials contained in this website are protected by applicable copyright and trademark law.

Submission of an online registration is regarded as a firm booking and acceptance of these terms and conditions. Cancellation charges will apply for all bookings.

Payment

Please note that payment of all fees must be made in full at the time of your registration. Registration valid only with full payment.

Payment can be made using one of the following method:

Credit or debit card – using our secure payment site as the final step of the registration process.

All registration details, including payment details, shall be sent via a secure WorldPay server.

Substitutions may be made at any time. If you wish to substitute a delegate, please contact the Conference Department at the earliest opportunity.

VAT

Value Added Tax (VAT) is payable by all delegates whether from Europe or overseas. Where VAT is applicable it is shown and calculated at the current standard rate. If the rate is altered as a result of government legislation charges may be adjusted accordingly. A tax invoice/receipt will be issued for all registration. The Malev Air Tours's VAT registration number is HU12396775.

Cancellation Policy

All cancellations, by individuals or groups, must be given in writing to the Malev Air Tours via Email.

For the events the following cancellation charges shall apply (unless otherwise indicated on the event website):

- if the written cancellation is received by the Malev Air Tours before the 01.01.2017, a full credit/refund will be issued
- if the written cancellation is received by the Malev Air Tours between 01.01 – 31.01.2017, a full credit/refund minus a 50% administrative charge will be issued
- if the written cancellation is received by the Malev Air Tours after 31.01.2017, or you do not attend the event, no refund will be issued

Liability

Delegates are required to comply with the rules and regulations governing the applicable venue and/or accommodation. The delegates shall insure and keep insured any property they bring onto the venue and/or the accommodation, and any such property is brought onto, or left, at the venue and/or the accommodation at their own risk.

Subject to the other provisions of this section (Liability), the Malev Air Tours shall only be liable to delegates for proven direct losses suffered due to the negligent acts or omissions of the Malev Air Tours and the Malev Air Tours's liability for these proven direct losses is limited in total to the amount paid by the delegate to the Malev Air Tours for the relevant event. The Malev Air Tours expressly excludes any liability for any property damage or loss incurred at any time during the event. The Malev Air Tours shall not be liable (whether such liability arises due to negligence, breach of contract, misrepresentation, or otherwise) for any direct losses or damages not stated above or for any indirect or consequential losses or damages howsoever arising. This shall include, but not be limited to, (and whether direct, indirect or consequential) loss of use or any profit, business, or data or any loss of use or damage suffered by any delegate as a result of an action brought by a third party, even if such loss was reasonably foreseeable or the Malev Air Tours had been advised of the possibility of the delegate incurring the same.

Nothing in these terms and conditions is intended to limit or exclude any liability which the Malev Air Tours is not able to limit or exclude by law including, but not limited to, liability for any fraudulent misrepresentation and/or for any death or personal injury caused by its negligence.

The delegates shall indemnify the Malev Air Tours, and keep the Malev Air Tours indemnified, for any costs, losses, or damages that the Malev Air Tours pays to the venue, accommodation or any other supplier connected to the event following (i) any breach by the any of the delegates of the relevant rules and regulations relating to the venue or accommodation; (ii) any damage done to that venue or accommodation or any equipment thereon by any of the delegates, including, but not limited to, any equipment provided for the event; and (iii) any injury suffered by any person, animal or item caused by or in consequence of any act or omission of any of the delegates.

Delegates must put in place appropriate insurance to cover any costs, liabilities or other losses that they may suffer or incur arising out of these terms and conditions (including the indemnity above), or arising out of their inability to attend the event for any reason (including any reason beyond their control). Delegates acknowledge that the Malev Air Tours shall not be liable for any costs or losses arising due to such cancellation or inability to attend, save to the extent expressly set out in these terms and conditions, and therefore it is their responsibility to ensure they have appropriate insurance.

Non Discrimination Policy

The Malev Air Tours will use its reasonable endeavours to comply with all Hungarian and European laws applicable in relation to discrimination on any grounds. Accordingly, the Malev Air Tours is committed to providing equality of opportunity and fair treatment for all. The Malev Air Tours will not intentionally discriminate on the basis of gender, age, marital status, sexual orientation, ethnic origin, religion, culture or disability in dealing with the delegates.

Data Protection

The information given to the Malev Air Tours by the delegates will be recorded in the Malev Air Tours's databases and will be used for marketing, administration and promotional purposes.

The Malev Air Tours may share this information with providers of services relating to the event (e.g. venues and hotels) for purposes of fulfilling your booking.

The Malev Air Tours is not responsible for the acts or omissions of any third party to whom it is entitled to pass delegates' information under this section.

Unless the Malev Air Tours receives an explicit written request in advance from a delegate confirming that they do not want to share their contact information, a list of all delegates, their affiliation institutions and Email addresses may be included in the delegate packs and on lists of delegates.

In addition, you acknowledge that the Malev Air Tours and/or its representatives and/or any delegate and/or attendee at the event may take photographs and/or video footage of all or part of it.
